

Classic Group Privacy Policy

This Privacy Policy applies, but is not limited to the activities of:

- Classic Group Entities and employees
- Managed Resorts/Clubs and employees
- Operations under licence

—as set out in Schedule A—hereinafter referred to as **Classic, We, Our, Us. You** and **Your** means the user or member of any product or service we provide.

Personal Information

In accordance with the Privacy Act, we collect personal information necessary for business purposes. We endeavour at all times to collect personal information in a fair and lawful manner, and to meet our customers' expectations that we will respect their right to control how their personal information is collected and used.

Further personal information may be collected to document or report any incident or accident at any premises owned, managed or leased by any entity or managed resort/club as set out in Schedule A.

You may gain access to, update or delete (if applicable) any personal information we hold about you. Such requests will usually be made available to you within 14 days. To protect your privacy, we will confirm your identity prior to providing this information.

Using and Disclosing your Personal Information

Classic uses your personal information to:

- Communicate with you, either electronically or by post
- Provide you with information about products or services
- Provide you with information about special promotions and offers
- Issue invoices and overdue payment notices
- Advise of pending membership expiry (where applicable)
- Ensure internal quality assurance

We do not share, sell, rent or distribute the information collected from you or about you to any third party without your permission. Classic may send the information about you to other companies or people when:

- It is necessary to provide you with a product or service that you have requested;
- Is required or authorised by law;
- It is required for insurance or medical purposes following an incident or accident;
- A third party product or service provider has been engaged; or
- It has your express consent to share the information.

Third Party Providers

Classic uses a range of third party providers to maximise the quality and efficiency of our business operations. Third party providers will sometimes have access to your personal information held by Classic and may use it providing a product or service on behalf of Classic. We require all third party providers to adhere to strict privacy guidelines and not to keep this information or use it for any unauthorised purposes.

Security

Classic is committed to high standards of data security with respect to information collected on our websites. We offer SSL encryption, the industry standard security measures for transactions made over the Internet.

Classic endeavours to take all reasonable steps to keep any information we hold about you secure, accurate and up to date. Classic uses a sophisticated computer data network, and all access to the computers and system devices are password controlled. Employees can only gain access to data if they are authorised.

We also require our employees and data processors to respect the confidentiality of any personal information held by Classic. Data is stored in a secure data centre environment, with daily backups of all data taken and a copy of all data kept offsite. Our data network is totally private and not accessible over the Internet. We use sophisticated detection and intrusion technologies to ensure that there are no network security breaches.
